You applied for asylum in Belgium. The CGRS will invite you to an interview. In order to be able to prepare this interview, we would like to ask you some questions about your family, your identity documents and the documents you used on your journey to Belgium. Therefore we ask you to complete this questionnaire. Your guardian received a copy of this questionnaire. You can ask for the help of your guardian and/or lawyer to complete this questionnaire.

Please return the completed questionnaire **within a month** on receipt by registered post, or you can ask your guardian to deposit the questionnaire at the reception desk of the CGRA.

The purpose of this questionnaire is **to assess your application promptly and thoroughly**. The more information you can provide us, the quicker we can assess your asylum application. If you don't know all of the answers, you can mention this in the questionnaire. However, it is in your interest to answer this questionnaire **to the fullest extent**. **Your help is very important**, so that you can rapidly receive a decision regarding your asylum application.

It is also important that you answer **truthfully**. If you give false or incorrect answers, your application for asylum can be refused or a protection status can be withdrawn afterwards.

You can add pages to this questionnaire should you not have enough space to answer the questions in full. You can ask your guardian or lawyer to take a copy of the documents in your possession and to attach them to the questionnaire. If your guardian and/or lawyer want to make remarks or give further explications, they can also add an extra page to the questionnaire.
